By taking part in this Sweepstakes you accept and agree to be bound by these Official Rules and agree that all decisions of NBA Entities (as defined below) are final and binding. The Sweepstakes is subject to all applicable federal, provincial and local laws and regulations and is void where prohibited by law. These Official Rules apply only to this Sweepstakes and not to any other promotions, contests, or sweepstakes by NBA Entities.

SWEEPSTAKES PERIOD:

The Sweepstakes begins on May 8, 2026 at 9:00 AM ET and ends on May 25, 2026 at 11:59:59 PM ET (the “**Sweepstakes Period**”).

ELIGIBILITY, RESIDENCY AND AGE:

To enter and to be eligible to win the Sweepstakes, entrants (including their guest) must be a legal resident of Canada and be eligible for entry into the United States. Valid passport is required and entrants must not be subject to any travel restrictions.
