NBA Paris Game 2020 Sweepstakes Official Rules. No Purchase Necessary To Participate Or Win.

- **1) Description**: The NBA Paris Game 2020 Sweepstakes ("Promotion") is a random draw promotion. Odds of winning depend upon the total number of eligible entries received during the Promotion Period .
- **2)** Eligibility: The Promotion is open to residents of the United Kingdom who are eighteen (18) years of age or older as of 9 January 2020 (each, an "Entrant").

Consenting to receive promotional emails is optional and is not required for participation in this Promotion, and will not impact your chances of winning. There is a limit one (1) entry per person and one (1) entry per email address. Additional registration forms or entries received from any person or any email address will be void. The use of script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void.

Incomplete entries will not be accepted and are automatically disqualified.

Entries made on behalf of another person will not be accepted and joint submissions are not allowed.

It is free to register and to participate in the Promotion.

5) Winner Determination: At or about 11:00am GMT on 18 January, 2020 (the "Draw Date"), one (1) potential Prize winner will be selected by random draw from among all eligible entries received in accordance with these Rules (as determined by the Promoter at its sole discretion). Odds of winning

depend upon the total number of eligible entries received by the Promoter during the Promotion Period.

6) Winner Notification: The Winner will be notified on or about 18 January 2020 by e-mail to the e-mail address provided during the registration process. Entrants are solely responsible for checking their e-mail inboxes to see if they are the Winner.

To claim the Prize the Winner must follow and complete the instructions in the win notification email within twenty-four (24) hours of the email notification being sent to the Winner.
