

NBA Paris Game 2020 Sweepstakes Official Rules.

No Purchase Necessary To Participate Or Win.

1) Description: The NBA Paris Game 2020 Sweepstakes ("Promotion") is a random draw promotion. Odds of winning depend upon the total number of eligible entries received during the Promotion Period .

2) Eligibility: The Promotion is open to residents of the United Kingdom who are eighteen (18) years of age or older as of 9 January 2020 (each, an "Entrant").

Employees, officers, directors, agents and representatives of The National Basketball Association ("NBA"), NBA Properties, Inc. ("Promoter"), NBA Media Ventures, LLC, NBA Digital, the NBA and its member teams (the "NBA Entities"), Turner Networks, teamDigital Promotions, Inc., and each of their respective parent companies, subsidiaries, affiliates, officers, governors, owners, distributors, retailers, agents, advertising/promotion agencies (hereafter collectively, the "Promotion Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate in the Promotion or to receive the Prize.

By entering the Promotion, you confirm that you are eligible to do so and are eligible to receive the Prize should you win. You may be required to provide proof that you are eligible to enter the Promotion and to receive the Prize should you win.

3) Promotion Period: The Promotion starts at 8:00:00AM GMT on 9 January 2020 and ends at 11:59:00PM GMT on 17 January 2020 ("Promotion Period"). All registrations must be completed and all entries must be submitted during the Promotion Period. All entries submitted after the end of the Promotion Period are automatically disqualified.

4) To Participate: During the Promotion Period visit nbasweepstakes.com/Paris2020 ("Website") and click on the banners, buttons and/or links to access the Promotion registration page. To register, complete and submit the Promotion registration form according to the instructions provided. Consenting to receive promotional emails is optional and is not required for participation in this Promotion, and will not impact your chances of winning. There is a **limit one (1) entry per person and one (1) entry per email address. Additional registration forms or entries received from any person or any email address will be void.** The use of script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void.

Incomplete entries will not be accepted and are automatically disqualified.

Entries made on behalf of another person will not be accepted and joint submissions are not allowed.

It is free to register and to participate in the Promotion.

5) Winner Determination: At or about 11:00am GMT on 18 January, 2020 (the "Draw Date"), one (1) potential Prize winner will be selected by random draw from among all eligible entries received in accordance with these Rules (as determined by the Promoter at its sole discretion). Odds of winning

depend upon the total number of eligible entries received by the Promoter during the Promotion Period.

6) Winner Notification: The Winner will be notified on or about 18 January 2020 by e-mail to the e-mail address provided during the registration process. Entrants are solely responsible for checking their e-mail inboxes to see if they are the Winner.

To claim the Prize the Winner must follow and complete the instructions in the win notification email within twenty-four (24) hours of the email notification being sent to the Winner. If the Winner does not claim the Prize within this timeframe, the Winner's claim will be invalid and the Promoter will re-award the Prize to an alternate Winner selected by random draw in accordance with these Official Rules.

The Promoter does not accept any responsibility if you are unable to claim the Prize.

The Prize may not be claimed by a third party on the Winner's behalf.

The Promoter must publish or make available information that indicates that a valid award took place. To comply with this obligation the Promoter will publish the surname and county of the Winner on nbasweepstakes.com within one month after the end of the Promotion Period.

If you object to any or all of your surname, county and winning entry being published or made available, please notify the Promoter. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.

The Winner will be required to sign and return an eligibility certificate and such other documents required by the Promoter within one (1) day of the date of receipt of the documents. The Winner's Guest (as defined below) (or the Winner himself / herself if the Guest is the Winner's child or other person for whom the Winner has legal parental responsibility) must also sign and return an eligibility certificate and such other documents required by the Promoter within one (1) day of the date of receipt of the documents. If the e-mail notifying the Winner is returned as undeliverable, and the Promoter's designated agent is unable to contact the Winner in any other manner within one (1) day of the email notification being sent to the Winner, or if a Winner is not in compliance with these Official Rules, the Winner will be disqualified and, time permitting, the Promoter will re-award the Prize to an alternate Winner selected by random draw in accordance with these Rules).

The Prize will be awarded to the person named on the applicable Promotion registration form regardless of whether that is the authorized account holder of the email address from which the registration form was submitted (subject to verification of eligibility and compliance with the terms of these Official Rules).

7) Prize: The Prize is a trip to the NBA Paris Game 2020 presented by beIN SPORTS for the Winner and one (1) guest (the "Guest") in Paris, France on 24 January 2020. The trip will consist of return economy-class air transportation (departing on 23 January 2020 and returning on 25 January 2020) from the major international airport nearest to the Winner's residence in the United Kingdom to Paris, France, and standard double-occupancy hotel accommodations, and two (2) two tickets to the 2020 NBA Paris Game (approximate retail value of prize package=1000GBP). Actual prize value will vary depending on the Winner's city of departure. Travel and hotel arrangements will be determined by the Promoter in its sole discretion and must be made through the Promoter's agent, on a carrier of the Promoter's choice. The trip must be taken on dates and times designated by the Promoter or the

Prize will be forfeited in its entirety and, time permitting, awarded to an alternate Winner that will be randomly selected from any other The Promoter reserves the right to change the times and dates. The Winner and the Guest must travel together on the same itinerary. The Guest must be at least 18 years old unless the Guest is the child or other person for whom the Winner has legal parental responsibility. The Winner and the Guest are responsible for obtaining all necessary travel documents, including passports and visas prior to travel. In the event that the Winner or his/her Guest fail to or are unable to obtain a passport or visa prior to trip departure date outlined above, or are unable to accept the Prize or are unable to travel or participate in any part of the Prize for any reason, the Winner in question will forfeit the Prize in its entirety and, time permitting, the Prize will be awarded to an alternate Winner that will be randomly selected from any other eligible Entrants. If the NBA Paris Game 2020 is canceled or postponed for any reason, the travel prize will be awarded less applicable prize-related activity(s) and the Promoter will substitute that activity(s) with an item(s)/activity(s) of comparable or greater value as determined solely by the Promoter and no additional compensation prize, cash or other alternative will be awarded to the Winner in such event. The Winner and the Guest must comply with all arena rules and regulations. Failure to do so may result in the forfeiture of the Prize element. Exact seat locations at games are to be determined by Promoter in its sole discretion. Certain travel restrictions may apply. The Prize is not negotiable or transferrable.

The Winner must make sure the Winner and the Guest have adequate travel insurance. If they do not hold adequate travel insurance, it is solely at the Winner's risk.

8) Miscellaneous: By participating in the Promotion, each Entrant accepts and agrees to accept and be bound by these Official Rules and by the decisions of the Promoter, which shall be final and binding in all respects.

No transfer, assignment, cash redemption, or substitution of the Prize (or portion thereof) is permitted. In the event that any element of the Prize becomes unavailable to award, the Promoter reserves the right to substitute the Prize (or portion thereof) with one of comparable or greater value as determined by Promoter.

All other costs and expenses associated with acceptance and use of the Prize not specified herein as being awarded are the Winner's sole responsibility (including but not limited to: the cost of travel to and from the hotel for the NBA Paris Game 2020; the cost of transfers to and from the departure and arrival airports; meal expenses; spending money; and travel insurance).

The Promotion Parties and their parents, affiliated and subsidiary companies and advertising and promotion agencies are not responsible for lost, incomplete, inaccurate, garbled, late, delayed, undelivered or misdirected entries, registrations, usernames, or NBA team submissions (including but not limited to the predictions, selections or revisions); theft, destruction or unauthorized access to, or alteration of, entries, registrations or NBA team submissions; failures or malfunctions of phones/mobile devices (including wireless phones/handsets or other wireless devices); interrupted or unavailable network, server, Internet Service Provider (ISP) or other connections; any error, omission, interruption, defect or delay in any transmission or communication; traffic congestion on the Internet or for any technical problem, including, but not limited to, any injury or damage to Entrant's or any other person's computer or mobile device related to or resulting from participation in this Promotion; printing errors in any Promotion-related advertisements or other materials; the cancellation, suspension or preemption of NBA games, scoring tabulation or timing errors.

Proof of transmission will not be deemed proof of entry into the Promotion.

By entering the Promotion, the Winner agrees to reimburse the Promotion Parties for any claim, action, liability, loss, injury or damage incurred by any of the Promotion Parties as a result of the acts or omissions of the Winner or the Guest.

The Promoter, in its sole discretion, reserves the right to: 1) disqualify any person who tampers with the submission process, the operation of the Promotion, or any other component of this Promotion, or who is otherwise in violation of these Official Rules; and 2) modify to the minimum extent necessary, suspend or terminate this Promotion (or any portion thereof) should virus, bugs, non-authorized human intervention or other causes, including but not limited to war, strikes, and/or acts of God, corrupt or impair the administration, security, fairness or proper play of this Promotion. The Promoter reserves the right to halt or modify the Promotion at any time if events beyond its control compromise the Promotion's fairness or integrity.

The Promoter reserves the right to modify these Official Rules for clarification purposes without materially affecting the Promotion. This is a Promotion designed to increase consumer awareness of and interest in the Promotion Parties' service.

In the event that the Promotion is challenged by any legal or regulatory authority, the Promoter reserves the right to discontinue or modify the Promotion. In such event, the Promoter shall have no liability to any Entrants who are disqualified due to such an action. In the event of any ambiguity(s) or error(s) in these Official Rules, the Promoter reserves the right to modify these Official Rules for clarification purposes or to correct any such ambiguity or error(s) without materially affecting the Promotion.

9) Limitation of Liability and Disclaimer of Warranties: If any of the Promotion Parties fail to comply with these Official Rules, they are not responsible for any loss or damage suffered by you that is not foreseeable. Loss or damage is foreseeable if either it is obvious that it will happen or if, at the time you entered the Promotion, both parties knew it might happen.

The Promotion Parties do not exclude or limit in any way their liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by negligence; for fraud or fraudulent misrepresentation.

The Promotion Parties are not liable for any business losses including loss of profit, loss of business, business interruption, or loss of business opportunity.

10) Privacy: The NBA Entities collect personal data from Entrants when they play the Promotion. Personal data collected from the Website is subject to the NBA privacy policy located at http://www.nba.com/news/privacy_policy.html#/ and will be handled consistent with that policy and subject to any specific privacy choices communicated to the NBA Entities. Personal information may also be disclosed to third parties solely to administer the Promotion and to award the Prize.

11) These Official Rules are governed by the laws of England and Wales. The courts of England and Wales shall have exclusive jurisdiction to hear any dispute or claim arising in association with the Promotion or these Official Rules.
